

### ■ DISTRIBUTION ■

The Group's products are distributed from logistics centres located to optimize transport efficiency. The Reference Product is therefore transported over an average distance of 780 km, essentially by road, representing a marketing in Europe.

Packaging is compliant with with european directive 2004/12/EC concerning packaging and packaging waste. At the packaging end of life, its recycling rate is of 97 % (as % of packaging weight).

#### ■ END OF LIFE ■

The product end-of-life factors are taken into account during the design phase. Dismantling and sorting of components or materials is made as easy as possible with a view to recycling or failing that, another form of reuse.

#### • Recyclability rate of the Reference Product:

Calculated using the method described in technical report IEC/TR 62635, the recyclability rate of the product is estimated at 100 %. This value is based on data collected from a technological channel operating on an industrial basis. It does not pre-validate the effective use of this channel for the end of life of this product.

Separated into:

- metal materials (excluding packaging) : 82 % - packaging (all types of materials) : 18 %



#### **■ ENVIRONMENTAL IMPACTS**

The evaluation of environmental impacts examines the stages of the Reference Product life cycle: manufacturing, distribution, installation, use and end-of-life. It is representative from products marketed and used in Europe, in compliance with the local current standards.
