This Reference Product comes from a site that has received ISO14001 certification. The final assembly site is located in Malaunay, France.



## ■ DISTRIBUTION

## END OF LIFE

The product end of life factors are taken into account during the design phase. Dismantling and sorting of components or materials is made as easy as possible with a view to recycling or, failing that, another form of reuse. This product falls within the scope of the WEEE Directive (2012/19/EU). Therefore it must be processed through local WEEE recycling/recovery channels.

### Elements to process specifically:
