

## ■ MANUFACTURE

This Reference Product comes from sites that has received ISO14001 certification.



## ■ DISTRIBUTION

Products are distributed from logistics centres located with a view to optimize transport efficiency. The Reference Product is therefore transported over an average distance of 1235 km by road from our warehouse to the local point of distribution into the market in Middle East.

Packaging is compliant with European directive 2004/12/EC concerning packaging and packaging waste. At their end of life the recyclability rate is 91 % (in % of packaging weight).

## END OF LIFE

Product end of life management is integrated into product design by the development teams. The disassembly and sorting of components or materials is made as easy as possible with a view to recycling or another form of reuse.

**• Recyclability rate:**

Calculated using the method given in technical report IEC/TR 62635, the recyclability rate of the product is estimated at 48 %.

This value is based on data collected from a technological channel operating on an industrial basis. It does not prejudge the effective use of the channel for electrical and electronic products at the end of their life.

Separated into:

- plastic materials (excluding packaging): 13 %
- metal materials (excluding packaging) : 28 %
- other materials (excluding packaging) : 0 %
- packaging (all types of materials) : 7 %



## ENVIRONMENTAL IMPACTS

The evaluation of environmental impacts examines the stages of the Reference Product life cycle: manufacturing, distribution, installation, use and end-of-life. It is representative from products marketed and used in Middle East.

The following modelling elements were taken into account:

<b>Manufacture</b>	Unit packaging taken into account. As required by the "PEP ecopassport" programme all transport for the manufacturing of the Reference Product, including materials and components, has been taken in account.
<b>Distribution</b>	Transport between the last Group distribution centre and an average delivery to the sales area.
<b>Installation</b>	Installation components not delivered with the product are not taken into account.
